### JOB TASKS

The Quality Technician assists in the inspection processes to ensure compliance with quality standards and organizational excellence.

### DUTIES AND RESPONSIBILITIES

- Inspect or perform audits on incoming material, using measuring and gaging tools and visual techniques in determining conformance to engineering specifications.
- Determine the method(s) and process(es) needed to measure part conformance, according to the allowed dimensional tolerances and normal gaging practices.
- Document, contain and report non-conformances to specifications using computerized quality documentation system.
- Insure the site's gage procedures and metrology program is current and accurate.
- Insure gages and equipment have accurate inventory levels, are in proper operating condition and certifications are current.
- Support information systems used in the inspection/audit process.
- Assist in data mining and analysis to focus the facility quality efforts.
- Assist in maintenance of process documentation and documentation control activities.
- Communicate professionally with suppliers of services, equipment and consumables.
- Other duties as assigned or required.
